

**BLUE MOUNTAIN PROPERTY OWNERS' ASSOCIATION
REQUIREMENTS REGARDING ALCOHOLIC BEVERAGES
AT
BLUE MOUNTAIN LODGE**

In accordance with **Title 4.1, Section 200 (10) of the Code of Virginia - Exemptions from licensure, Virginia Code, Title 4.1 - ALCOHOLIC BEVERAGE CONTROL ACT, Chapter 3, Paragraph 4.1-316 - Keeping or drinking alcoholic beverages upon premises of club; penalty**, any person who is **not** a Blue Mountain property owner and is hosting an event at Blue Mountain Lodge (or any Blue Mountain Common Area) must obtain and post a special event (one-day) ABC license. The following information pertains:

Banquet (also known as one-day) licenses are issued to non-property owners for private events where alcohol is provided at no charge to guests, such as wedding receptions, retirement parties, etc.

Banquet special event and mixed beverage special event licenses are issued to duly organized, nonprofit corporations and associations raising money for athletic, charitable, civic, educational, political, or religious purposes and not for personal monetary gain.

Tasting licenses allow the sale or giving of samples for the purpose of educating the consuming public about alcoholic beverages being tasted.

Online Banquet License Application

The Department of Alcoholic Beverage Control has developed an Internet Banquet License Application that allows you to apply and pay for a banquet license from the convenience of your home or office. You may use your credit card via the Web.

You may apply for your Banquet License online: <https://www.abc.virginia.gov/licenses/get-a-license/banquet-licenses> (Control Click to follow this link). Follow the instructions on each page, complete the application, and submit.

A copy of the license must be provided to the Lodge Coordinator or her designated representative at least one month prior to the event and must be prominently posted at the event. For licensing requirements the address of the Lodge is: 540 Cliff Road, Linden, VA 22642.

Note: Do not use this address for mailing purposes; mail is not delivered to/received at this address. The address is primarily for fire/rescue and directional purposes. The following page provides an explanation of the various licenses/qualifications/fees.

Banquet	This license is issued to individuals (representing themselves or a group/company) for a private event that is not for monetary gain, where alcohol is provided at no charge to guests. Also known as a “one-day” license.	Authorizes complimentary beer, wine or mixed beverages; guests may bring their own alcohol. Beer and/or wine sales (not for profit).	\$40 - State license fee + <u>\$15 - Nonrefundable fee</u> \$55 - Single-day rate + \$40 - Each additional day
Banquet-Special Event	This license is issued to duly organized, nonprofit corporations or associations raising money for athletic, charitable, civic, educational, political or religious purposes. Event is not for personal monetary gain.	Authorizes beer and/or wine sales, or guests may bring their own alcohol. (Note: This does not authorize the sale of mixed beverages.)	\$40 - State license fee + <u>\$15 - Nonrefundable fee</u> \$55 - Single-day rate + \$40 - Each additional day
Mixed Beverage Special Event	This license is issued to duly organized, nonprofit corporations or associations raising money for athletic, charitable, civic, educational, political or religious purposes. Event is not for personal monetary gain.	Authorizes mixed beverage sales, or guests may bring their own alcohol. (Note: This does not authorize the sale of wine or beer.)	\$45 - State license fee + <u>\$15 - Nonrefundable fee</u> \$60 - Single-day rate + \$45 - Each additional day
Banquet / Mixed Beverage Special Event	This license is issued to duly organized, nonprofit corporations or associations raising money for athletic, charitable, civic, educational, political or religious purposes. Event is not for personal monetary gain.	Authorizes beer, wine and mixed beverage sales, or guests may bring their own alcohol.	\$85 – State license fee + <u>\$30 – Nonrefundable fee</u> \$115 - Single-day rate + \$85 Each additional day
Tasting License	This license is issued to a business or an individual who is not prohibited from holding an ABC license and wishes to sell or give samples for the purpose of educating the consuming public about the alcoholic beverages being tasted.	Authorizes the sale or complimentary samples of beer, wine and/or mixed beverages in approved localities. Restrictions apply on amounts and types of alcohol (§4.1-221.1).	\$40 - State license fee + <u>\$15 - Nonrefundable fee</u> \$55 - Single-day rate + \$40 - Each additional day
